THE PREVENTION AND SUPPRESSION OF MONEY

This Law may be cited as the Prevention and Suppression of Money Laundering and Terrorist Financing Laws of 2007-2013. 2.-(1) For the purposes of this Law, unless the context otherwise requires- Interpretation.
